MINUTES

Hanover Area Junior/Senior High School Hanover Township, Pennsylvania August 1, 2023

A Regular Meeting of the Board of School Directors of the Hanover Area School District was held on Tuesday, August 1, 2023, at 7:00PM. The meeting was called to order by the Board Vice President, Dr. Vic Kopko.

Mr. Potsko noted that he did have more information on the subject if anyone from the Board or the Public had any questions.
